**Hawai'i Department of Taxation Warns Taxpayers**  
**Regarding "Distrainment Warrant" and Other Scams**

**FOR IMMEDIATE RELEASE**

June 1, 2023

HONOLULU – The Hawai'i Department of Taxation (Department) is cautioning taxpayers about recent activity in Hawai'i involving tax-related scams, including phishing attempts in the form of text messages, mailed letters, social media messages, or emails.

Hawai'i taxpayers have reported receiving messages and letters asking to click a link or call a phone number. It might be an intimidating letter about "Distrainment Warrants," using messages such as "seizure or forfeiture may be imminent due to non-payment of taxes," or letting the taxpayer know they can claim money. A sample "distrainment warrant" is provided below. These are not official letters, emails or texts from the **State of Hawai'i Department of Taxation**, which does not issue "Distrainment Warrants," send text messages, post social media messages about taxes owed, or send unsolicited emails.

Do not reply to any correspondence from the "Hawai'i Department of Revenue" or "Tax Assessment Securities." They have no association with government in Hawai'i—it is a scam. Do not click on the link, open an attachment, or call the phone number; they are just trying to capture your personal information, solicit business, or take your money.

**SEIZURE OR FORFEITURE MAY BE IMMINENT DUE TO NON-PAYMENT OF TAXES**

This warrant has been issued against [REDACTED] due to non-payment of a seriously delinquent tax debt. The liability has not been paid. This letter serves as a final judgmental notice.

The State Of Hawaii can now take enforcement action such as seizing Social Security benefits, garnishing wages and bank accounts to satisfy the outstanding debt owed. If no action is taken by 5/29/2023 the State Of Hawaii may revoke benefits, suspend licenses, and levy or offset any tax refund gained this year.

Your debt must be satisfied in full or settled to remove the levy. To avoid enforcement, call within fifteen (15) days of receiving this notice. Failure to respond may result in additional penalties, fees and interest.

*In the event any amount other than costs recovered shall be credited against the tax liability for the collection of which such levy is made. This is not a bill. As a Taxpayer, you have the right to pay only the amount of tax legally due.*
