REPORT COUNCILMEMBERS COMMUNICATION WITH STAKEHOLDERS

Chair Giesting reported the groups with whom the Commissioners have discussed TRC business. No communication with stakeholders was reported.

PRESENTATION ON CARBON TAX ASSESSMENT FOR HAWAII ECONOMIC AND GREENHOUSE GAS IMPACTS BY MAKENA COFFMAN, DIRECTOR, INSTITUTE FOR SUSTAINABILITY AND RESILIENCE PROFESSOR, URBAN AND REGIONAL PLANNING RESEARCH FELLOW, UHERO

Professor Makena Coffman made a presentation on Carbon Tax Assessment for Hawaii Economic and Greenhouse Gas Impacts. [The presentation is posted on the TRC website.]

QUESTION AND COMMENTS FROM PRESETATION ON CARBON TAX STUDY

Chair Giesting opened the meeting for discussion to Dr. Coffman's presentation by asking the Commission if there were any questions.

Ms. Lloyd brought attention to a question asked from the public made by Ms. Nicole Woo about the differences in consumption patterns between the five income quintiles. How does Professor Makena Coffman's model account for the differences between the five income quintiles in their response to the carbon tax?

Dr. Makena stated that the model internally updates the changes over time relative to the baseline.

Dr. Seth Colby asked if Professor Makena Coffman could give her thoughts on the rationale for carbon tax at the state level from the following three standpoints 1. Environmental 2. Distribution 3. Revenue.

Dr. Coffman said that the social cost of carbon is valid for the State of Hawaii. She also said that the issue of a carbon tax is best addressed at the national level

Mr. Clay added that the cost of carbon and the cost of climate change in Hawaii would typically be higher than the world on average.

Chair Giesting followed up by commenting on the importance of taxes and the incentives that are given to those who could afford to get PV, electric vehicles, energy efficient appliances, etc. She said that the dividends, which tend to be disproportionately favor lower income households, may still not be enough to incentivize people to make that conversion due to varying factors such as bigger households, no parking space, etc.
